3. HAZARDS IDENTIFICATION

Main hazards: Extremely flammable. Irritating to eyes. Possible risk of harm to the unborn child. Repeated

exposure may cause skin dryness or cracking. Vapours may cause drowsiness and dizziness.

Other hazards: In use, may form flammable / explosive vapour-air mixture.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be irritation and redness at the site of contact.

Eye contact: There may be irritation and redness. The eyes may water profusely.

Ingestion: There may be soreness and redness of the mouth and throat.

Inhalation: There may be irritation of the throat with a feeling of tightness in the chest. Exposure may cause

5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Refer to section 8 of SDS for personal protection details. If outside do not approach from

downwind. If outside keep bystanders upwind and away from danger point. Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid. Eliminate all sources of ignition.

Environmental precautions: Do not discharge into drains or rivers. Contain the spillage using bunding.

Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by Clean-up procedures:

an appropriate method. Do not use equipment in clean-up procedure which may produce

sparks.

7. HANDLING AND STORAGE
