3.2 POTENTIAL HEALTH EFFECTS

Eye Contact:

7.1 HANDLING

8.2 PERSONAL PROTECTIVE EQUIPMENT (PPE)

8.2.1 Eye/Face Protection

8.2.2 Skin Protection
